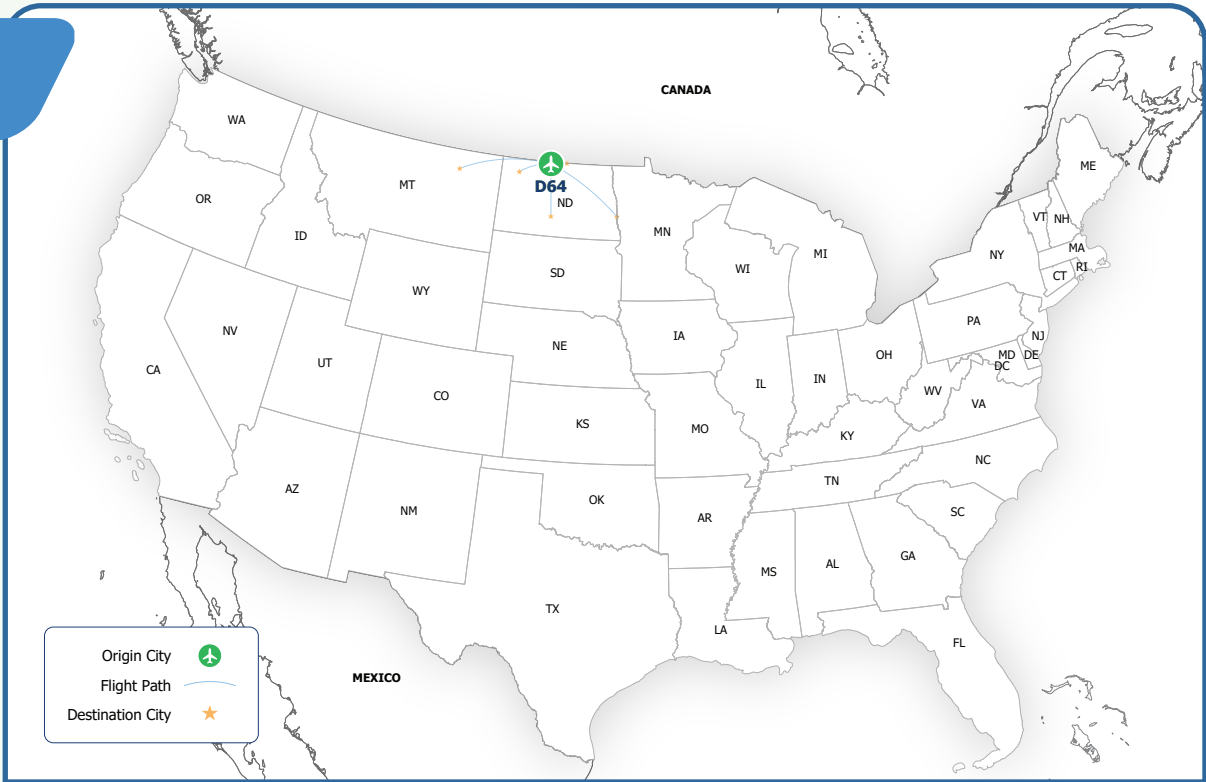

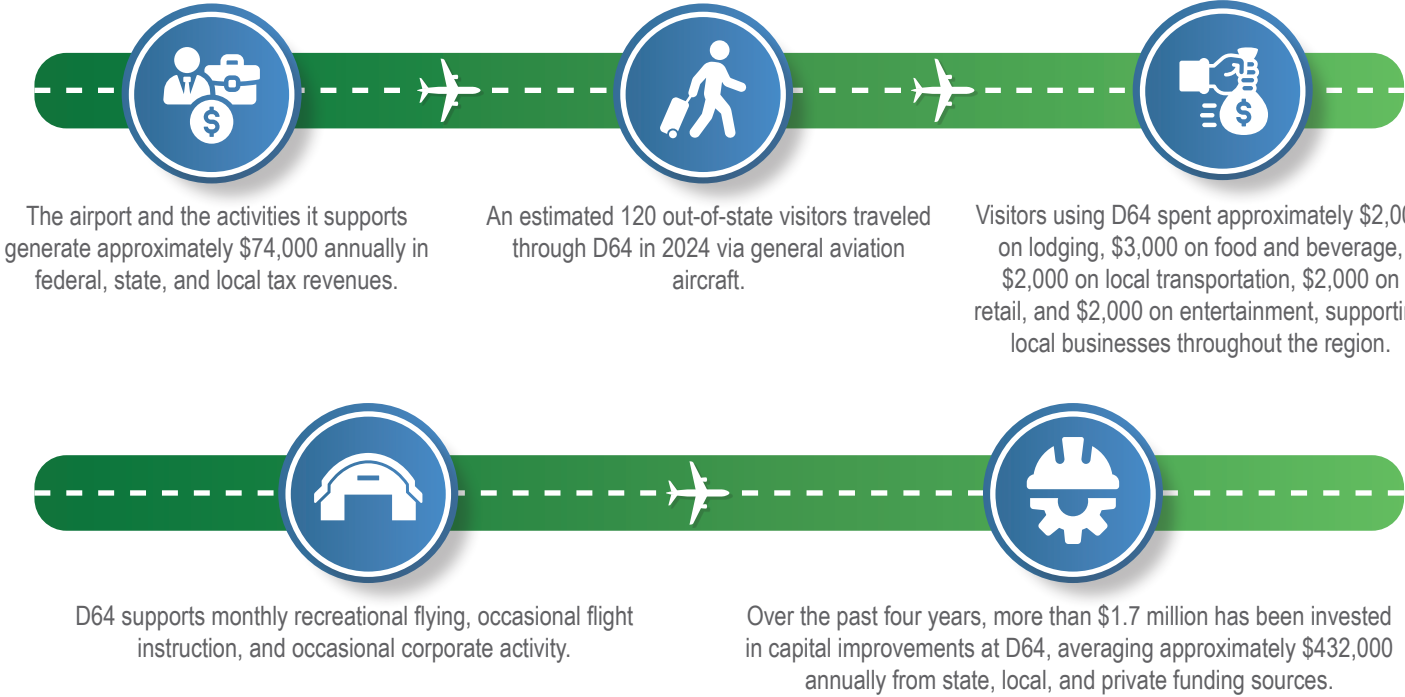
Airport Flight Map

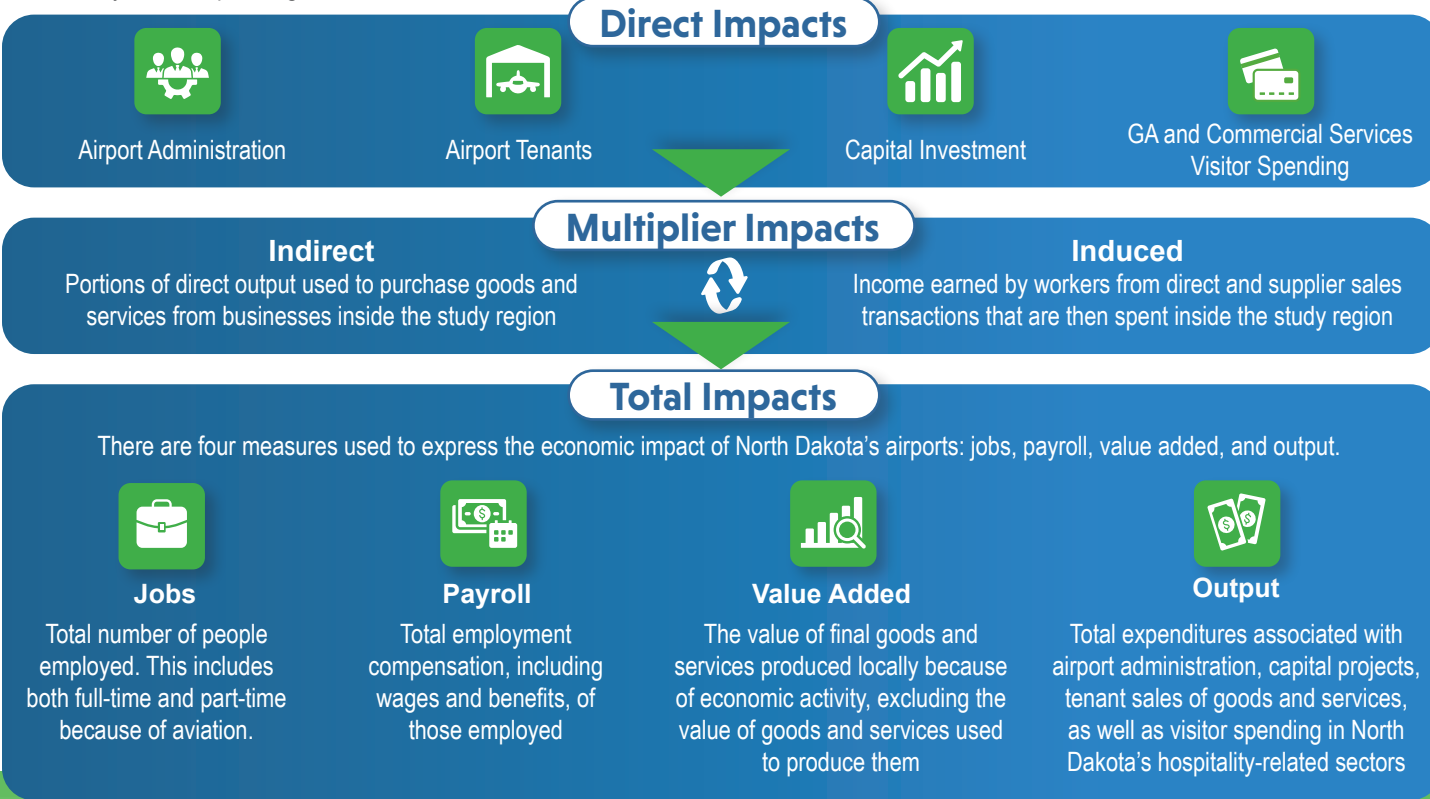


Study Methodology

Comprehensive data collection was essential to producing accurate economic impact estimates for calendar year 2024. Primary data sources, including airport staff, airport business tenants, and visitors, were used to estimate direct economic impacts. These data were gathered through onsite visits and a combination of in-person, telephone, and online surveys. Where needed, additional industry sources were consulted to supplement the primary data. A nationally recognized economic modeling platform, IMPLAN, was used to calculate multiplier effects. Economic impacts were estimated for airport management, airport tenants, capital investment activity, GA visitor spending, and commercial service visitor spending.

Economic Impact Levels

The economic impacts for North Dakota's airports are presented at three distinct levels (direct, multiplier, and total) to describe where in the economic cycle the impact is generated.



About Westhope Municipal Airport

Located just west of the city of Westhope in Bottineau County, Westhope Municipal Airport (D64) is a small but meaningful part of North Dakota's aviation network. With an asphalt runway and open airspace, the airport provides reliable access for general aviation, agricultural spraying, and seasonal flying. Its rural location and straightforward layout make it especially well-suited for aerial application services, which are vital to the productivity of surrounding farmland. Though the airport operates without a control tower or on-site maintenance facilities, it remains a valuable resource for local pilots and agricultural operators. The Westhope Airport Authority oversees the facility, ensuring it remains accessible and functional for day-use operations year-round, with snow removal in place to support safe operations. Westhope itself is a historic community founded in 1903 along the Great Northern Railway, known for its agricultural heritage and close-knit character. The airport complements this legacy by supporting crop management, emergency access, and regional mobility. Whether serving farmers, recreational pilots, or visiting professionals, Westhope Municipal Airport continues to reflect the resilience and utility of rural aviation in North Dakota.
