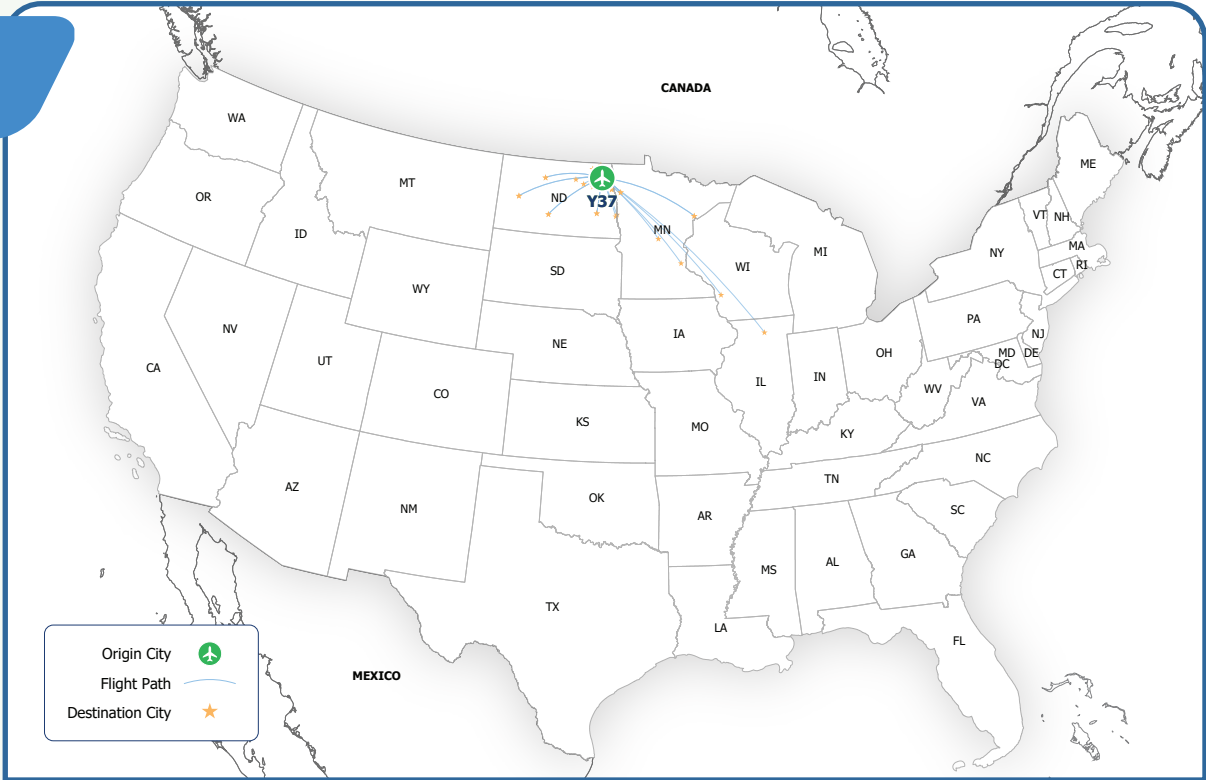

Airport Facts

The airport and the activities it supports generate more than \$176,000 annually in federal, state, and local tax revenues.

An estimated 1,422 out-of-state visitors traveled through Y37 in 2024 via general aviation aircraft.

Visitors using Y37 spent approximately \$23,000 on lodging, \$40,000 on food and beverage, \$25,000 on local transportation, \$27,000 on retail, and \$22,000 on entertainment, supporting local businesses throughout the region.

Y37 offers 100LL services to based and transient aircraft, allowing the airport to support a variety of critical operations, such as flight instruction, recreational flying, and medevac.

Over the past four years, more than \$2.0 million has been invested in capital improvements at Y37, averaging approximately \$503,000 annually from federal, state, local, and private funding sources.

Study Methodology

Comprehensive data collection was essential to producing accurate economic impact estimates for calendar year 2024. Primary data sources, including airport staff, airport business tenants, and visitors, were used to estimate direct economic impacts. These data were gathered through onsite visits and a combination of in-person, telephone, and online surveys. Where needed, additional industry sources were consulted to supplement the primary data. A nationally recognized economic modeling platform, IMPLAN, was used to calculate multiplier effects. Economic impacts were estimated for airport management, airport tenants, capital investment activity, GA visitor spending, and commercial service visitor spending.

Economic Impact Levels

The economic impacts for North Dakota's airports are presented at three distinct levels (direct, multiplier, and total) to describe where in the economic cycle the impact is generated.

Park River - W.C. Skjerven Field (Y37) is a versatile general aviation airport serving the heart of Walsh County, North Dakota. Located just one mile west of Park River in northeastern North Dakota, the airport features two runways, offering flexibility for a range of aircraft and seasonal operations. With 100LL and Jet-A fuel available, the airport is well-equipped to support both transient and local aviation needs. The airport's value extends beyond infrastructure; it's deeply connected to the agricultural and civic life of Park River. Known as "The Town With a Heart," Park River is a proud rural community with strong farming roots, vibrant local businesses, and a welcoming spirit. The airport supports aerial application services, emergency access, and recreational flying, making it a vital tool for productivity and mobility in the region. Managed by the Park River Airport Authority, W.C. Skjerven Field exemplifies how small airports can deliver big impact—serving as a gateway to the skies and a reflection of the community's resilience, resourcefulness, and pride.
